McCALL'S STOLEN CROWN OF THORNS.

Massachusetts' Eloquent Congressman Will Speak To-Night.

REASON TO THE FRONT.

National Congressional Committeeman Apsley Will Address the Meeting.

THEIR WORK IN COLORADO.

They Hearded the Lion in His Den and Held Overflow Meetings in Two Places There.

Congressman S. W. McCall of Massachusetts and L. D. Apsley of the same State, vice-chairman of the Republican National Congressional Committee, will speak on the issues of the campaign this evening at the Auditorium, corner of Eddy and Jones streets.

Congressman McCall has achieved great reputation as a speaker. He represents the Eighth District of Massachusetts, in which Harvard College is situated, and is the originator of the expression, "pressing a crown of thorns upon the brow of labor," which expression was stolen by Bryan, and used by him with great effect at Chicago.

Mr. McCall is a forceful and logical speaker, and has but few equals in the United States. He and Mr. Apsley hearded the silver lion in his den, and had overflow meetings in Colorado Springs and Colorado City, at which they were granted not only respectful attention, but liberal applause. This arose from the fact that more than one-half of both audiences were Republicans and supporters of McKinley and protection to American labor.

The meeting to-night will be held under the auspices of the Republican State Central Committee. George A. Knight will preside. The gallery will be reserved for ladies and their escorts.

The executive committee of the National Republican League will meet this evening in the headquarters, Pioneer building. Business of importance will be transacted and all the members are requested to attend.

The executive committee of the Republican State Central Committee will hold a meeting at the latter end of this week for the purpose of filling the vacancy on the electoral ticket.

Francis A. Tee, ex-District Attorney of Madera County, one of the brightest lawyers in Central California, was in the City to-day. He expressed the opinion that McKinley and protection. SUNFLOWER'S INVITATION

His Audience Asked to Attend His Trial in the Police Court.

The Alleged Obstructor of the Streets Addresses a Large Open-Air Meeting.

"I invite you all to come and see a free man in a free country tried like a criminal for exercising his inalienable right of free speech." Thus did Charles D. Sunflower address a crowded open-air audience last night on Pine street, just below its intersection with Kearny. The sidewalks were kept clear, but the middle of the street was closely packed. Though applause was frequent and enthusiasm manifest the throng was at least as orderly as the average audience in any theater or lecture-hall. Now and then a policeman would glance at the assemblage from an adjacent street corner, but the meeting was not disturbed nor the speaker in any way molested by the minions of the law.

"Yes, gentlemen," went on Sunflower, "I am a prisoner at large, so to speak, simply because I am a Socialist, and because I did what I had a right to do. If free speech be a crime, then I am a criminal, and a self-confessed one; but if such be the case, then let all lovers of freedom seek some other aid where they can be free in fact as well as in name. Come on Thursday, all of you, and see a free man tried for saying what he thought—or rather for thinking alone, since I was arrested at the very meeting last Saturday near the Old Fellows' hall. On that this land was truly free."

Abie addresses were also delivered by E. T. Kingsley, the Socialist nominee for Congress, George Street and Mark Lettles. The last named speaker took occasion to dwell at some length upon THE CALL's impartial treatment of the recent conflict between the Socialists and the police authorities.

"I fail to understand the attitude of the other papers," he observed. "THE CALL alone has handled our late difficulty with courtesy and consideration. Its reports of the various phases of the affair have been full and accurate, and I have reason and authority for saying that the Socialist Labor party, while not surprised at THE CALL's dignified and fair treatment, is most grateful for it."

Yesterday morning the five Socialists arrested on Saturday night came up for trial in Judge Conlan's court. The first case was that of Sunflower, who demanded a jury trial. His attorney, Mr. Haskell, asked the judge to demand the fact that his client feared that if tried by the judge alone he might be acquitted, whereas it was desired to appeal the cases to the supreme court for final adjudication. The demand was allowed, and the cases continued until Thursday of this week.

Reports from the various sections throughout the City and State are most encouraging. Several thousand signatures have been obtained to the petition asking that the names of the Socialist candidates be placed on the official ballots, and the party's prospects seem to be bright.

Trustee Martin gave an eloquent presentation of his reasons for deserting Democracy and becoming a follower of the man of Ohio. He declared that his prof views had not changed, but added: "I cannot support a party which advocates the collection of less revenue than is necessary to pay our obligations; that threatens to discourage and disorganize our entire monetary system; that advocates the supremacy of mobs and riots, and that proposes to make our court of last resort a convenient tool to act in accordance with every vicious whim or caprice of our Chief Executive or Congress."

Trustee Martin vigorously attacked the recent course of the Democracy, especially in the passage of the Wilson bill, and proceeded to declare against the "free-silver craze."

He declared that free coinage would make a profit of \$19,000,000 a year for silver mine owners, giving statistics in substantiation of his statements.

"I do not conceive that there can be any permanent increase in the price of silver bullion by the proposed legislation," said Mr. Martin, "nor is there any necessity for an advance in order that the present silver mine owners may become the Rothschilds of the world in a few years."

"The American people rejected this noble man for the Presidency and placed in the executive chair Grover Cleveland, an owl who has sat on the dried limb of decadence and hooted calamity from the Republican party, the man who has been rejected by his own party and declared to be good for nothing but fishing for cod or mackerel."

"Yes, and he went in on promises—big promises, small promises, hoary-headed promises and promises in the bargain stage. The intention now is to place in the seat which he will shortly vacate William J. Bryan, who has been on the stump only a short time, and yet already has a record for promises that would trow Grover's into the shade."

"Bryan is not only a promise-maker, but he is a demagogue, a free-trader, a Populist-Democrat and the foremost believer in the free coinage of silver in the country. He is a free-silver man, a free-silver man—one who is willing to bring on financial anarchy and consequent chaos in order to further his own selfish aims."

With the remark that he would have something further to say on this subject at another period in his address the speaker gave a glowing description of the record of the Republican party, stating that though it was conservative yet the list of reforms inaugurated under its administration would make that of any other party sink into insignificance in comparison. After a review of the financial policy of the Democratic and Republican parties, the speaker entered upon the issue between free trade and protection, which he said is the only important issue before the people.

"It is free trade," he said, "that shut up the factories and turned the workmen out of their doors. It was free trade that brought this country where it is now. The Democrats know this, and this talk about free silver is only a subterfuge to cover the real issue beneath a pile of words."
